No telephone cancellations will be accepted. A \$50 administrative fee will be deducted from each refund. Cancellations received after July 21 cannot be refunded. Registrations are transferable to another individual prior to the Conference start date; registered no-shows will be billed.

Cancellation of Booth Space
