Federal funding opportunity: Youth and young adults at high risk for psychosis

The purpose of this program is to provide trauma-informed, evidence-based interventions to youth and young adults (up to 25 years of age) who are at clinical high risk for psychosis. This program is intended to prevent or lessen the severity of psychotic disorders among youth and young adults.

STOP Violence Against Women Formula Grant

PCCD announces the availability of up to \$12 million in federal STOP Violence Against Women Formula Grant funding for projects beginning January 1, 2025.

County governments and non-profit victim service agencies are eligible to apply for up to three years of funding, with projects not to exceed a total of \$375,000 or \$125,000 per year. Visit the [PCCD e-grants page](#) for more information.
