REMINDER – PComp Safety and Wellness Grant Applications are due by December 1st, 2024

The **PComp Safety Improvement Program Grant** supports safety committees and administrations by awarding grants to offset the costs of safety improvements to protect employees, assist workers' compensation efforts in reducing accident frequency and severity, while enhancing their safety and risk management programs. The maximum grant amount is \$35,000 per member, up to a maximum of 75% of the member's annual contribution.

The **PComp Wellness Improvement Program Grant** supports members by awarding wellness grants to offset the costs of wellness programs and activities. The grant amount is \$5,000 per member.

PComp members must submit their fully completed and signed Safety and Wellness grant applications by the end of business on December 1, 2024. Grant applications will be considered, assessed and subject to PComp's grant offering and requirements.

Safety and Wellness at Work

On September 10, 2024, CCAP's Wellness and Safety Committees joined forces to offer Stop the Bleed training to staff. Guest speaker, Phil Lucas, Public Safety Director from Mifflin County, led the instruction and provided coaching to staff during live demonstration on training manikins. During this training, staff learned the ABC's of bleeding control and the value of a tourniquet. Bleeding is the number one cause of preventable death after injury, and educated responders can quickly become the difference between life and death in these emergency situations.

The Manager's Role in Boosting Employee Confidence

Have you ever been in a situation where you were expected to complete a task but didn't have the tools or know-how? Have you ever completed a task well but failed to receive the recognition you thought it deserved?

Suppose you replied yes. You know how struggling with confidence at work feels. If you can't feel confident in your work, don't believe it is valued, and/or feel like there is no direction for your job, you know how challenging it is to put in effort and find motivation.

It is a genuinely negative feeling, and, as a manager, you should strive to prevent your employees from feeling this way. While you cannot change timid people into bold ones (they have to want that for themselves), you *can* encourage confidence and promote a more robust working environment by providing the following:

- Provide Adequate Training Training and adequately orienting your employees is vital to preventing stress and the lack of confidence that results from a lack of training. Educating your staff on new technology and trends will give them the confidence to stay afloat and relevant in ever-changing workplaces.
- Offer Consistent Recognition The performance levels of your employees will increase the more frequently you acknowledge their successes. And don't wait for the significant achievements to recognize success – make sure you offer recognition for even the more minor achievements your employees meet.
- **Listen to Your Employees** -If you provide a space within your department where your employees can come and talk and process what is going on in their world, you will increase their confidence simply through active listening. Employees who feel like they are being heard and who see changes made due to speaking up will have much greater confidence and pride in their work than those who do not.
- **Give Timely Feedback** Staff members want to know they are doing a good job right away not weeks down the line. Additionally, be timely in

- notifying your employees about changes they could make. This will give them the ability to change unwanted behaviors sooner rather than later, leading to greater success for their work output immediately, not when the unwanted behavior has turned into an unwanted habit.
- Be Encouraging in the Face of Mistakes -No one is perfect, and not one employee will be flawless in their work performance. Oddly, your staff is self-criticizing enough as it is, so when it comes to addressing mistakes, be encouraging. Offer additional training, if needed, but ensure that with mistakes comes the chance to learn and make improvements for the next time.






prison facility are eligible for services, regardless of whether they hold PIMCC program membership.

Defensive Driving


On Friday, July 26th, Lebanon County hosted a Defensive Driving training workshop courtesy of CCAP Insurance Programs. Kelly Kyzer, Risk Control Specialist and Certified Defensive Driving Instructor, led the 4-hour training session, which was attended by Lebanon County employees and included attendees from neighboring



counties. The training included blind spot awareness, maintaining safe following distance, and risk prediction, among other key components.

According to <u>defensivedriving.org</u>, **6,337 people are injured in motor vehicle crashes daily, with human error being responsible for 94% of all accidents.** By educating staff on simple preventative measures they can take to mitigate vehicular harm, counties can promote safer roadways for all travelers.
