## America250PA's 2024-25 Semiquincentennial Grants

America250PA (A250PA) is Pennsylvania's official commission responsible for planning and coordinating all programming, projects, and events related to the United States' 250th anniversary in 2026.

With funding support from Governor Josh Shapiro and the Pennsylvania Legislature, A250PA is pleased to award \$1 million in grant funding across two grant periods during their 2024-25 Fiscal Year. ## **PCCD State Endowment Act Funds Announced**

The Pennsylvania Commission on Crime and Delinquency (PCCD) has announced the availability of state Endowment Act funds for **Developing Satellite CACs-2022-25**. This solicitation is for Category 2- Multidisciplinary Investigative Teams (MDIT) of the Endowment Fund

Funding under this category is limited to supporting the development of satellite location(s) in counties in the Commonwealth that may not have enough child abuse cases to sustain an independent CAC.

Approximately \$1,200,000 in state Endowment Act funds is being announced to support this initiative. PCCD expects to fund approximately four grants. Maximum awards of \$300,000 are available for the three-year project period.

These funds are eligible to any NCA-accredited CAC that, in conjunction and partnership with another county MDIT, seeks to develop a satellite CAC location within that county. A satellite location can be developed in a county that currently does not have a CAC or an NCA Affiliate member.

**Applicants will be expected to submit a letter of intent from the MDIT members of the impacted counties (e.g., applicant county and potential satellite county) to [RA-PCCD-CACAC@pa.gov](mailto:RA-PCCD-CACAC@pa.gov) and participate in a call/meeting with PCCD and PENNCAC staff before applying.**

## **PCCD STOP Violence Against Women SART Grant**

The PCCD Office of Victims' Services (OVS) is offering up to \$870,000 in federal **STOP Violence Against Women Formula Grant** funding for projects starting July 1, 2025.

County governments and non-profit victim service agencies can apply for up to three years of funding. Applicants will submit a budget for Year 1, with Years 2 and 3 awarded through continuation applications.

The funding aims to improve responses to sexual assault by:

1. Creating new Sexual Assault Response Teams (SARTs) in communities without one.
2. Enhancing existing teams in communities that already have them.

Applications must be submitted in PCCD's **Egrants** system no later than **Monday, December 2, 2024**.



## **Lawrence County to Create Veterans Park**

As reported in the New Castle News, a state grant of \$13,400 has been awarded to Lawrence County to help create a master site development plan for a veterans park on land adjacent to the courthouse.

The grant, provided through the Pennsylvania Department of Conservation and Natural Resources Community Conservation Partnerships Program, will fund the planning process for a one-acre triangular parcel the county cleared in 2022.

Attorney Thomas Shumaker, a former commissioner, and Wilmington Township resident, initially proposed the park to honor veterans.

County officials, including Commissioner Chairman Dan Vogler and Veteran's Affairs Director Jesse Putnam, are working together to bring Shumaker's vision to life.
